

## **CRITERIA and GUIDELINES for RECOMMENDATIONS for SWIMMING QLD AWARDS**

### **Brisbane Swimming nominates appropriate persons for consideration by SQ for the following SQ awards**

FOR THESE GUIDELINES, IT IS NOT NECESSARY FOR EACH AND EVERY POINT TO BE SATISFIED IN EACH CATEGORY.

#### **SQ Life Membership**

- Has actively served SQ for an appropriate period of time as determined by the SQ Awards Sub-Committee and ratified by the Board, not necessarily consecutive, as an administrator, official, coach or volunteer/supporter.
- As a swimmer, has competed successfully internationally as a member of Australian teams for an appropriate period of time as determined by the SQ Awards Sub-Committee and ratified by the Board, Also to have been actively involved in clinics or promotions organised by SQ
- Considered to have contributed outstandingly to the development of the sport through their work to swimmers, officials, coaches and administrators, eg
  - actively involved in the development of swimmers especially as a coach, administrator or official in the service of SQ in an outstanding manner.
  - through their work as a coach have brought SQ renown (for the good of the sport) and the coach has unselfishly and actively helped in the development of up and coming coaches again in an outstanding manner.
  - as an official has officiated at a high standard with respect to a good knowledge of the rules and in applying equity to all participants of the sport. Has unselfishly and actively contributed to the development of new officials through their work as an examiner, mentor and lecturer.
  - as an administrator has unselfishly and actively helped other administrators at regional and club level in the development of the sport in an outstanding manner. Has also helped to coordinate the above development of swimmers, coaches and officials thereby obtaining a high standing of SQ in Australia and the world.
  - as a volunteer/supporter has contributed significantly and beyond measure in their support of SQ
- All recipients are considered to have enhanced the standing of SQ at state +/- or national +/- or international levels through their excellent work.
- Unlawful serious misdemeanours or offences will not bar elevation to Life Membership unless any serious misdemeanour or offence is, in the judgement of the SQ Awards Sub-Committee and ratified by the Board, of a nature to be harmful to the reputation and standing of Swimming Queensland and its Members.



- The Board is of the opinion that the above attributes are above and beyond that which would be expected in the normal function of their duties.

#### **SQ Award of Excellence**

- Service to swimming in Qld whether at Club, Regional +/-or State level.
- Considered to have given a high order of service to the sport through their untiring commitment in any position.
- Considered to have contributed to the development of the sport through their work to swimmers, coaches, officials, administrators and volunteers through their excellent work.
- To have served an appropriate period of time as determined by the SQ Awards Sub-Committee and ratified by the Board, not necessarily consecutive, in the sport in Qld.
- To be instigated by SQ with the advice of the particular Club +/-or Region
